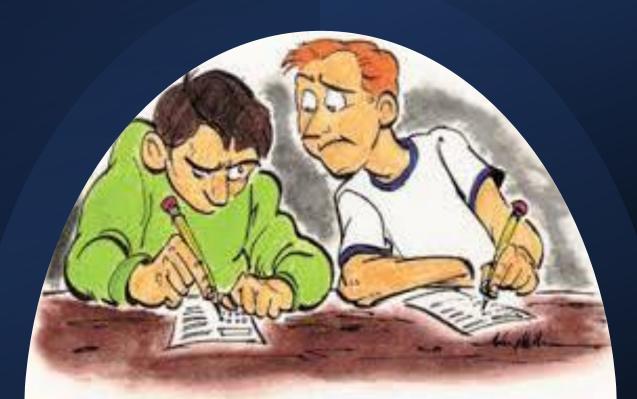



Behavior Conduct vs. Academic Integrity

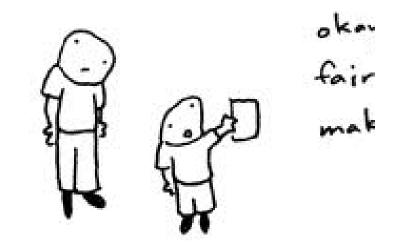
- Academic integrity violations are not behavior violations
- They are an academic issue
- How to handle violations is the purview of faculty
- What is the difference?



Internal Education



- Faculty
 - Policy and procedures follow process; report cases
 - Violations/Sanctions what can you do?
 - How can you BE SPECIFIC?
- Academic administrators
 - Policy and procedures
 - What is your role?



What Are Current Issues?

- Online delivery:
- Cheating/plagiarism/forgery
- Assessment are there different types?
- Specificity on syllabi:
- What does this mean?
- Is it the same for all classes?
- Should I put more than the policy link?
- Students have due process rights

Processes

Penalty Options for Faculty to Issue:

(Section II, A – E of the UNT Academic Integrity Policy.)

- Admonition
- Educational coursework
- Partial or no credit for assignment/assessment
- Course failure
- Lower grade
- Note: Each violation must be reported separately

Processes Faculty Should Follow

• Good faith effort to contact student (in writing; UNT email; provide specifics)

• Student has 5 days to respond

• If student responds, you must schedule a meeting (virtual or in person before you file)

• If you choose to file, see Single Violation Report form

Students' Rights

- Student may appeal to Department Chair within 5 days of the instructor's written decision
- Student files Appeal of Single Violation form

Department Chair Responsibilities

- 10 days to complete each appeal
- Meet with student and faculty member (policy says "may")
- •Chair may:
- Uphold appeal and penalty
- Overturn appeal and penalty
- Modify penalty
- **Department Chair must c**omplete **Appeal Finding** form for case to be considered closed

>When does the AI officer team step in?

Multiple or egregious violations

- ➤We meet with student
- ➤May assign more serious sanctions:
 - ➢ Probation
 - ➤Suspension

Students' Rights

- Right to know reasons for the accusation
- Right to know reasons for the sanction
- Right to privacy (FERPA)
- Right to appeal accusation or severity of sanction
- Right to remain in class and/or continue in program until appeal is resolved
