The CHE faculty adopts the *College of Education Expectations for Reappointment,*Tenure, and Promotion document to serve as its guidelines for reappointment, tenure, and promotion of tenure-track faculty members, along with the following Addendum.

# Addendum to CHE Tenure-Track Reappointment, Tenure, and Promotion Policy

Tenure track faculty are expected to publish their research in journals appropriate for their field and/or research issues. As stated in the College of Education Expectations for Reappointment, Tenure, and Promotion, candidates for tenure and promotion to Associate Professor are expected to have published a core of at least 10 scholarly articles by the time of promotion. Also, candidates for promotion to Professor are expected to have published a core of at least 20 scholarly articles – in total – by the time of promotion.

Reputable journals are those identified by individual faculty members and deemed by the RPTC as appropriate to the field, or research issues based on the following additional quality criteria: (a) the journal must employ a peer review process, and (b) the journal must be used as a dissemination outlet by peers at research universities. Of 10 expected articles for tenure and promotion to Associate Professor, at least three should be published as a first author with at least one first-authored publication in a top tier journal. Of the 20 expected articles for promotion to Professor, six would typically be published as first author and at least 30% would be in top tier journals.

Top tier journals are reputable journals which also meet one or more of the following criteria: (a) a published acceptance rate of 30% or less, (b) a Journal Citation Reports (JCR) Impact Factor of 1.0 or higher, or (c) a Scientific Journal Rankings (SJR) H Index of 20 or

higher. Faculty members seeking reappointment, tenure, and promotion will format their vitae using the attached 18 CHE Vita Template and 18 CHE Journal Metric Data for Vitae.

Journals will be initially assessed for quality by the faculty member seeking reappointment, tenure, and promotion and then confirmed by the CHE RPTC. In addition to criteria previously stated, faculty members are expected to consider order of authorship, consistency of publication frequency, and publication citation rate as evidence of developing or establishing a national/international scholarly reputation.

Although scholarly articles may include empirically-based and theoretical publications, a candidate for tenure and/or promotion is expected to have a higher concentration of empirically-based articles. Publications outside of top-tier journals are considered to be contributory to a credible scholarly reputation as faculty members establish a consistent publication record. While candidates for tenure and promotion to Associate are expected to concentrate on developing a scholarly reputation through peer-reviewed publications, candidates for promotion to Professor should also consider publication indicators of scholarly leadership through first authorships, refereed books, and grants.

# **Documenting Journal Metrics on COE/CHE Vitae**

In compiling your vita, if you are promotion-eligible such as assistant or associate professor, divide your journal articles into Data-based and Concept-based; professors need not differentiate. Under each entry, using journal metric data for the year of article publication, indicate (a) if available, 5-year Journal Impact Factor (*JIF5*) and JIF percentile (*JIF %ile*) OR Scimago Journal Rank (*SJR*) and quartile (*SJQ*), (b) Cabells acceptance rate (*AR*) or, if no Cabells entry for your journal, *AR* as reported to you by the journal editor, (c) circulation rate, and (d) authorship statement, including % contribution. If you like, you may also include major Counseling or Higher Education professional association journal affiliation where relevant, such as *ACA journal* or *ASHE journal*—and other vital info such as awards.

\*\*\*Beginning with merit review in 2018, only articles published 2015-2017 are required to include journal metric data – though you may want to include it for all your journal pubs.

The four primary journal metrics:

- 1. JIF5 5-year at year of pub
  - Cite: *JIF5* = x.x (*JCR*, [year])

JIF percentile – compares JIF to other journals in same and related fields

- Cite: *JIF* %*ile* = x.x (*JCR*, [year])
- 2. If JIF not available, use SJR ranking (only one-year IF shown) and quartile (no exact percentile available)
  - Cite: SJR = xx (Scimago, [year]) and  $SJQ = 1^{st}$ ,  $2^{nd}$ ,  $3^{rd}$ , or  $4^{th}$  (Scimago, [year])
- 3. Cabells acceptance rate
  - Cite: AR = x% (Cabells, [year]) or, if not listed in Cabells, AR = x% (Editor, [year])
- 4. Major professional association journal affiliation
  - Cite: ACA journal or ASHE journal
